- 2- The cost of affiliation form will be Rs. 1,000/- per affiliation form for the session 2019-20.
- 3- For extension of Temporary/Provisional Affiliation fee will be charged 50% amount as per above chart for B.A., B.Sc, B.Com. Pass. Course, M.A., M.Sc., M.Com. for other professional courses full fee will be charged.
- 4- Increase intake affiliation fee will be charged as per section wise i.e. Rs. 66,550/- per section( 10% fee will be increased on the basis of amount of basic fee of previous year Rs. 60,500/-)+GST\*
- 5- The Colleges applying for Fresh/Increase intake/Additional Subjects/Temporary Affiliation/Permanent Affiliation are required to pay an inspection fee of Rs. 20,000/-+GST\* each. The inspection fee of Rs.20,000/-(As per BOM Resolution No. 33 Dated 06.09.2017 and Resolution (Table Agenda) No. 14 Dated 28.03.2018 )

Note: Clause 4.10 of UGC (Affiliation of colleges by Universities) Regulations, 2009 and Pandit Deendayal Upadhyaya Shekhawati University (Affiliation of colleges by Universities) Regulations, 2018 states:

"Continuation of temporary affiliation of the programmes of study and the college itself shall be granted by the University on a year to year basis through inspection process prescribed in these Regulations,"

- 6- It is also clarified that seats which will be requested by the college for increase intake mentioned in the affiliation form, may be given by the university as per Pandit Deendayal Upadhyaya Shekhawati University (Affiliation of colleges by Universities) Regulations, 2018 after inspection done by the inspection team & decision taken by the BOI as per university affiliation rules.
- 7- No Objection Certificate of the state government must be submitted along with the affiliation forms.
- 8- The existing colleges will be required to fill up AISHE code. The new colleges will apply for new AISHE code. The college who have already taken AISHE code write number in the box.
- 9- Demand Draft will be payable in the favour of REGISTRAR, PANDIT DEENDAYAL UPADHYAYA SHEKHAWATI UNIVERSITY, SIKAR.
